# Flatten, Recycle, Repeat! CARDBOARD RECYCLING MADE EASY

Hey eco-warriors! Did you know that recycling cardboard is a breeze when you follow these simple steps? Let's break it down:





# STEP 1

# **Break It Down!**

Break down your cardboard boxes using a utility knife or pulling the box apart.

# STEP 2

# **Check Inside!**

Open the cardboard boxes and remove any packing peanuts or Styrofoam. These materials can't be recycled with cardboard and need to go separately. Let's keep our recycling stream clean!

# STEP 3

# Flatten It!

Before taking your cardboard to your nearest recycling drop off, make sure it's as flat as a pancake. Why? Flattened cardboard takes up less space and helps recycling facilities run more efficiently. It also ensures that more cardboard can be collected; stops are less frequent saving time, money, and gas; and reduces the number of bins placed at a site.

# WHY RECYCLE CARDBOARD?

# **Resource Conservation:**

Recycling cardboard reduces the need for cutting down trees. It's a simple way to conserve our natural resources.

# **Energy Savings:**

Recycling cardboard takes less energy than making new cardboard from scratch. It's an energy-efficient choice!

# **Environmental Impact:**

It prevents cardboard from ending up in landfills, where it contributes to waste and takes years to decompose.

#### **Closed Loop:**

When we recycle cardboard, it can be turned into new cardboard products, creating a sustainable, closed-loop system. You are participating in the circular economy!

Let's all do our part by recycling cardboard the right way! It's a small action with a big impact on our environment. Share these tips with your friends to spread the recycling love!

Remember, a little flattening goes a long way in making our planet greener and cleaner!



#### Aerosols

An aerosol can is a self-contained dispensing system where a substance is stored inside a small metal canister and pushed out as a fine mist, a spray, or a foam. Aerosol cans should be recycled at the Canton Recycle Center by appointment (330-874-2258, opt. 1). Place all recyclables in a reusable tote or cardboard box when transporting (not in a plastic bag).

# **Aluminum Foil**

Aluminum foil is not recylcable and should be reused or thrown away in your trash.



#### **Antifreeze**

Also known as coolant, antifreeze is an additive which lowers the freezing point of a water-based liquid and is commonly used in cars and trucks. Antifreeze is typically a fluorescent color when it is unopened. It's sometimes



mixed with other liquids such oil or gas. Please let the recycling attendants know what it is mixed with to assure the safest sorting and disposal. Anitfreeze can be recycled at STW Recycling's Household Hazardous Waste facility. Call the Canton Recycle Center at 330-874-2258, option 1 to make an appointment.

# **Appliances**

Many types of household appliances can be donated or recycled, including large and small appliances like washers, dryers, refrigerators, stoves, toasters, blenders and vacuum



cleaners. If your appliance is in good working condition, please consider donating it. Appliances that contain refrigerants, such as refrigerators and dehumidifiers, may not be accepted at all locations or may be charged a fee to be recycled. If purchasing a new large appliance, check to see whether they will collect your old appliance for recycling when delivering a new item. Some recycling locations may only accept small appliances, while others may only accept large appliances. Please read the accepting entity's website carefully and call ahead!

#### **Batteries**

#### \*Lead Acid and Small Sealed Lead Acid (Pb)

Household lead acid batteries are typically found in cars or trucks but can also be found in emergency devices, emergency exit signs, security systems, mobility scooters and UPS back-ups. Small Sealed Lead Acid (SSLA/Pb) batteries are simple to manufacture and have one of the lowest discharge rates of any rechargeable batteries. These batteries can be recycled by appointment at the Canton Recycle Center (330-874-2258, opt. 1)

#### **Batteries**

# \*Rechargeable (Nickel Cadmium, Nickel Metal-hydride, Lithium Ion)

Household batteries include rechargeable batteries in a variety of sizes (AA, AAA, 9v, etc.). The use of rechargeable batteries is recommended to reduce the



number of batteries being disposed of each year. Rechargeable batteries should never be put in your curbside or drop-off recycling container. They can cause fires at the local recycling facility and put recycling workers at risk. If you choose to recycle

household batteries through a mail-in program, retail store, or a Call2Recycle location, please safely prepare them for recycling – keep each battery in its own clear plastic bag before placing it in a storage container or tape the battery terminals with clear packing tape or non-conductive electrical or duct tape, keeping the label visible so that the battery type can be identified. These batteries can be recycled at participating Lowes and Home Depot stores. Call ahead to verify they accept these materials. They can also be recycled at the Canton Recycle Center – make an appointment by calling 330-874-2258, opt. 1.

#### **Batteries**

#### \*Single Use (Alkaline, Carbon Zinc, Manganese)

Modern-day alkaline, carbon zinc, and manganese batteries no longer contain mercury, are classified as nontoxic by the Environmental Protection Agency and can be disposed of in household trash. Lithium primary batteries should never be put in your curbside or drop-off recycling container. They can cause fires at the local recycling facility and put recycling workers at risk. If you choose to recycle household batteries through a mail-in program, retail store,

or a Call2Recycle location, please safely prepare them for recycling – keep each battery in its own clear plastic



bag before placing it in a storage container or tape the battery terminals with clear packing tape or nonconductive electrical or duct tape, keeping the label visible so that the battery tupe can be identified.

# **Batteries**

#### \*Single Use (Lithium Primary)

Lithium Primary Batteries should never be put in your curbside or drop-off recycling container. They can cause fires at the local recycling facility and put recycling workers at risk. These batteries can be recycled at participating Lowes and Home Depot stores. Call ahead to verify they accept these materials. They can also be recycled at the Canton Recycle Center – make an appointment by calling 330-874-2258, opt. 1.

#### **Books**

Books are not recyclable. Please consider donating your gently used books to another organization like Goodwill, or taking them to Slesnick in Canton, Ohio. If they are not in good enough condition to donate, they may be placed in the trash.



# **Campaign Signs**

Campaign signs are not recyclable and should be thrown away in your trash.



# Cardboard

Many types of cardboard items are recyclable. Please flatten your cardboard boxes prior to putting them in your recycling container. Broken-



down cardboard is accepted in all residential curbside recycling programs and at all STW drop-off recycling locations.

# Carpet

Carpet is not recyclable and should be thrown away in your trash. Contact your waste hauler ahead of time for pick-up instructions.

#### Cartons

Cartons like milk and juice cartons are not recyclable in STW Recycling District's public recycling bins. Some curbside recycling programs allow for cartons in their recycling stream – be sure to contact your hauler to verify.



# **Cell Phones & Cell Phone Batteries**

Cell phones and cell phone batteries should NEVER be put in your curbside or drop-off recycling container. They can cause fires at the local recycling facility and put recycling workers at risk. You can recycle cell phones and cell phone batteries by making an appointment at the Canton Recycle Center (330-874-2258, opt. 1). Participating Verizon, Lowes, Home Depot, and Best Buy stores, among other locations, also recycle these used items. Do not remove the battery

from the phone. If the cell phone battery is not in a cell phone, to safely prepare it for recycling either place each battery in its own clear plastic bag before placing it in a storage container or tape the battery terminals with clear packing tape or non-conductive electrical or duct tape, keeping the label visible so that the battery type can be identified.

# Ceramics (Broken)

Ceramics are not recyclable and should be thrown away in your trash.





# **Clothing & Textiles**

Clothing, coats, shoes, purses, belts, linens and other similar items may be donated to a large number of charitable organizations and buu-back shops like Goodwill or the

Salvation Army. Clothes and linens do not have to be in perfect condition to be accepted by some charitable organizations. Goodwill, for example, will accept items with holes or significant wear and recycle into rags. Your items should be clean.



# **Cups (Paper & Plastic)**

Paper and plastic cups are not recyclable and should be thrown away in your trash.



# **Diapers**

Diapers are not recyclable and should be thrown away in your trash or consider switching to cloth diapers.



# **Coffee Pods**

Coffee pods are not recyclable and should be thrown away in your trash or consider switching to a reusable or compostable pod.



# **Compact Flourescent Light Bulbs**


Compact fluorescent light bulbs, or CFLs, (the small twisty type of light bulb) contain a small amount of mercury and should be recycled whenever possible. They should never be put in your curbside or drop-off recycling container.

Broken CFLs can release mercury vapor and should be cleaned up using EPA recommendations. The EPA recommends that you DO NOT VACUUM the area where the bulb broke. Other light bulbs such as LED, incandescent and halogen bulbs are safe to dispose of in the trash. CFLs can be recycled at STW Recycling's permanent Household Hazardous Waste facility at the Canton Recycle Center year round. Make an appointment by calling 330-874-2258, opt. 1.

#### **Electronics**

Many types of electronic devices can be donated or recycled, including televisions, computers, laptops, tablets, printers, calculators, cables, power supplies and similar items. If your electronic device is in good working condition,

please consider donating it. Electronics can

# **Fertilizers**

Fertilizers are any natural or artificial substance containing chemical elements that improve the growth and productivity of plants. Unlinke natural fertilizers, artificial fertilizers contain chemical elements

which are hazardous to humans and should be disposed of properly. Fertilizers can contain petroleum products – these items are treated as flammable and must be kept away from sources of heat. We recommend finding

a nursery to donate your fertilizers to or find someone local who can use it in their garden.



# Film & Stretch Plastic

Film and stretch plastic are not recyclable and should be thrown away in your trash.



# Fire Extinguishers

Fire extinguishers are classified as cylinders and must be recycled properly. Residents of Stark, Tuscarawas and Wayne Counties may recycle their fire extinguishers at Pitt's Fire Extinguisher in Massillon, Ohio for a fee. Please call ahead of time to verify at 330-833-5508.



# Flower Pots & Accessories



Check with your local nursery to see if they can reuse your old flower pots and accessories. Otherwise, items should be placed in your trash.

# **Food Waste & Scraps**

Food waste and scraps can be accepted at two local facilities: Earth N Wood and Paradise Compost.



# **Furniture**

Usable furniture in good condition can be donated to many charitable organizations in the STW Recycling District. The Salvation Army, Goodwill and Habitat Restore are just some of the great organizations that take many of these



their requirements. Furniture in any condition should not be dropped at any of our recycling drop offs. This is considered illegal dumping. Your waste hauler should be called to verify their bulk items pick-up policy in the event you wish to throw the items away. Fees may apply.

# Gasoline, Kerosene & Diesel

Flammable liquids should be transported with care. Be aware of your exposure to vapors as you drive and transport these materials in approved containers only. Gasoline, kerosene and diesel, among many other things, can be recycled at STW Recycling's permanent Household Hazardous Waste Center by calling 330-874-2258, opt. 1 (by appointment only).

# Glass Bottles & Jars



All colors of glass bottles and jars are recyclale. Labels do not need to be removed. Please rinse containers and ensure they are clean, dry and empty. Put lids back on if possible and they will be recycled too (no corks). Glass bottles and jars are accepted in all residential curbside recycling programs and at all STW drop-off recycling locations.

# **Helium Tanks**

Do not place helium tanks in your curbside recycling or trash as they are considered hazardous. Empty helium balloon tanks that were purchased from a retail store should be punctured and recycled at a local scrap metal yard. You may receive a rebate. Follow the disposal instructions that came with the tank or visit balloontime.com for more information. Helium tanks are not accepted at STW Recycling's Household Hazardous Waste Center.



# **Household Cleaners**

Households generate a wide range of poisonous, dangerous, flammable and corrosive products, including lawn chemicals, solvents, household cleaners and pool chemicals. Please consider buying less

hazardous alternatives when possible! These materials should never be placed in with your household garbage. Household cleaners can be recycled at STW Recycling's permanent Household Hazardous Waste facility at the Canton Recycle Center year round. Make an appointment by calling 330-874-2258, opt. 1.





#### **Mattresses**

Mattresses must be disposed of in a landfill. Contact your trash hauler for their requirements.

If you do not have a hauler, contact Kimble at 330-454-9400.

# Mercury & Mercury-Containing Devices



Mercury is a dangerous chemical element that is often seen in items like thermometers, mercury switches, mercury relays, fluorescent lamps and other devices. It's also something you may have in a container by itself. It's heavy and is silver in color. These materials should not be placed in with your household garbage. They should be taken to a Household Hazardous Waste facility or collection event whenever possible. STW Recycling operates a permanent Household Hazardous Waste Center that accepts a wide variety of common household hazardous materials – make an appointment today by calling 330-874-2258, opt. 1.

# **Metal Cans**

Steel and aluminum cans are accepted for recycling in all residential curbside recycling programs and at all STW drop-off recycling locations. Labels do not need to be removed. Please rinse containers when necessary.

See "Scrap Metal" for options on recycling other metal objects.

# **Mirrors and Glass Windows**

Broken mirrors and glass windows are not recyclable and should be thrown away in your trash. If not broken, consider donating your mirror or glass window.



#### **Motor Oil**

Motor oil can recycled at the Canton Recycle Center by appointment only (330-874-2258, opt. 1). Motor oil does not have to be clean. If it is mixed with another substance

like gasoline, let the attendants know at dropoff. You may also drop off your motor oil at participating Autozones near you. Note: motor oil should never be used to kill weeds or as a dust suppressant on dirt or gravel roads, burned or poured down the drain or sewer.

# SAFE LATEX PAINT DISPOSAL

Disposing of latex paint safely is easier than you might think, and using kitty litter is a cost-effective and eco-friendly method. Here's how you do it:



- Select an appropriate container: You can use a partially full paint can or transfer the paint to a smaller container to minimize space. Make sure the container is something you can dispose of later.
- 2. Add kitty litter: Pour enough kitty litter into the container to thoroughly absorb the paint. The general rule of thumb is a 1:1 ratio of kitty litter to paint, but you might need more depending on the consistency of the paint.
- Mix and wait: Stir the kitty litter and paint together until the mixture has a thick, oatmeal-like consistency. Let it sit for about

- an hour to allow the kitty litter to fully absorb the paint. For larger amounts or thicker paints, it might take longer.
- **4. Check the consistency:** The paint should be completely dry and hard. If it's still wet, add more kitty litter and wait longer.
- 5. Dispose responsibly: Once the paint is solidified, you can safely throw the container in your regular household trash.

By following these simple steps, you can dispose of latex paint in an environmentally friendly way without hassle.

# **Needles & Sharps**

Hypodermic needles and other medical "sharps" pose a significant health threat to recycling and sanitation workers and should NEVER be put in your curbside or drop-off recycling container. The safest option is to use an FDAcleared sharps container to protect your family members, health workers, and sanitation workers prior to disposing of sharps. These containers are widely available at pharmacies and other retail stores. If one is not available, simply use an empty laundry detergent jug. Place the needle inside the empty laundry detergent jug. Place the cap back on securely. Tape the lid on and write "sharps" on the container. Dispose of the jug in your trash, not in your recycling. Call your local health department with questions.



# Paint - Oil-Based

Oil-based paint and similar products like paint thinner and solvents are flammable and hazardous. These materials should not be placed in with your household garbage but

should be taken to a household hazardous waste facility or collection event whenever possible.



Please consider buying less hazardous alternatives. Oil-based paint can be taken to STW Recycling's permanent Household Hazardous Waste Center by making an appointment at 330-874-2258, opt. 1.

# **Pallets**

Contact Tri-County Pallet at 330-848-0313.



# Oxugen Tanks

Return your oxygen tank back to the company that provided it - check the tank's label for contact information. If no such label exists, check with your medical supplier for details about their takeback or exchange program.

> If you are unable to determine where the oxygen tank came from, recycle the tank at a scrap metal yard. Determine if the tank is aluminum

> > or stainless steel (magnets stick to stainless steel, not aluminum). Find a scrap metal yard by searching with your zip code at yellowpages.com. Call ahead to confirm tanks. You can also try AAA Gas Supply (216-228-4800), ABC Fire (440-237-6677) and AirGas Great Lakes (216-241-1696) for cylinder recycling options.

# **Paper Towels**

Paper towels are not recyclable and should be thrown away in your trash.



# Paper, Magazines & Mail

Paper such as office paper, junk mail, newspaper,

magazines and paper grocery bags are accepted in all residential curbside recucling programs and at all STW

> drop-off recycling locations. Note: if the paper is coated with a plastic coating or foil, it is not accepted. Generally, if you can tear a paper item with your hands, it's recyclable.



# Paint - Latex

Latex paint should be dried out using kitty litter, newspaper or sand. Once dried, it can be thrown away. Latex paint is not accepted at the Canton Recycle Center. For oil-based paint, see "Paint - Oil-Based" above.



# **Pesticides**

Households generate a wide range of poisonous, dangerous, flammable and corrosive products, including lawn chemicals, solvents, household cleaners and pool chemicals. Please consider buying less hazardous alternatives when possible! These materials should never be placed in with your household garbage. STW Recycling operates a permanent Household Hazardous Waste Center that accepts a wide variety of common household hazardous materials - make an appointment today by calling 330-874-2258, opt. 1.



# **ECO-FRIENDLY PESTICIDE ALTERNATIVES**

Exploring alternatives to traditional chemical pesticides is an excellent way to protect your garden while preserving the surrounding ecosystem. Here are some effective, environmentally friendly options:

- Biological Controls: Utilize natural predators or parasites of pests. For example, ladybugs and lacewings are effective against aphids, and nematodes can control soil-borne insect larvae.
- 2. Cultural Practices: Change your gardening practices to make the environment less inviting to pests. This can include rotating crops, selecting pest-resistant plant varieties and removing plant debris that can harbor pests.

- 3. Mechanical and Physical Barriers:
  Use physical barriers like row
  covers or nets to prevent pests
  from reaching plants. Handpicking
  larger pests like beetles and
  caterpillars can also be
  surprisingly effective.
- 4. Botanical Insecticides: These are made from plants and are generally less toxic than synthetic chemicals. Neem oil, pyrethrin and essential oils can repel or kill pests without the harsh impacts of conventional pesticides.
- 5. Soil Health: Enhancing soil health through the addition of organic matter and maintaining a balanced pH can strengthen plants' natural defense against pests.

By integrating these alternatives into your gardening practices, you can reduce reliance on chemical pesticides and foster a healthier, more sustainable garden environment.



#### **Pharmaceuticals**

To safely dispose of leftover pharmaceuticals from home, take them to a pharmaceutical drop-off location or a temporary collection event.

Find pharmaceutical drop-off locations in Stark, Tuscarawas and Wayne counties at timetorecycle.org.

Note: only pills can be disposed of at collection sites. Sharps are not accepted – see "Needles & Sharps" for more information. Unused medicine that is left in the home creates a high risk of accidental overdose and illegal abuse if not properly disposed. Flushing medication down the toilet can contribute to water contamination and therefore is not recommended.

# **Plastic Bags**

Many local grocers have plastic bag recycling in their stores. Check your local grocer for more details. If not, place the plastic bag in your trash or reuse it.



# **Plastic Bottles & Jugs**

All plastic bottles and jugs with a neck and shoulders are accepted in all residential curbside recycling programs and at all STW drop-off recycling locations. Please rinse out with water when necessary and put the cap or lid back on.



# **Plastic Toys**

Do not place plastic toys in curbside recycling. If in good condition, please donate plastic toys to one of many

charitable organizations. If the item cannot be donated for reuse, place it in the regular trash for disposal. Consider participating in a take-back program for toys such as Lego Replay or Mattel PlayBack where these toys will be donated to charities or recycled into new toys.

# Plastics (Durable)

Do not place durable plastic items such as buckets, hangers, milk crates, storage containers, kids furniture,



toys or playsets in your recycling. If in good working condition, please donate these items to one of many charitable organizations. If the item cannot be donated for reuse, place it in the regular trash for disposal.

# Polystyrene (Styrofoam)

Polystyrene is not recyclable and should be thrown away in your trash.



# **Pool Chemicals**

Households generate a wide range of poisonous, dangerous, flammable and corrosive products including lawn chemicals, solvents, household cleaners and pool chemicals. These materials should not be placed in your household garbage but should be taken to a household hazardous waste facility or collection event. Please consider buying less hazardous alternatives when possible. STW Recycling operates a permanent Household Hazardous Waste Center that accepts a wide variety of common household hazardous materials – make an appointment today by calling 330-874-2258, opt. 1.

# SAFE PRESCRIPTION DRUG DISPOSAL

Disposing of prescription drugs safely is important to prevent misuse and protect the environment. Here's a quick guide on how to do it properly:

- 1. Prescription Pills Only: The best way to dispose of most types of prescription pills is through a drug take-back program. The STW Recycling District supports drug disposal locations throughout Stark, Tuscarawas, and Wayne Counties, providing a secure and environmentally safe way to dispose of unused or expired
- medications. Check your local police department for locations near you or visit timetorecycle.org
- 2. FDA Guidelines: If a take-back program is not available, the FDA recommends checking if your medication is on the list of those that can be flushed down the toilet due to safety risks from accidental ingestion or misuse. This list is available on the FDA's website.
- **3. Household Trash Disposal:** For drugs not on the flush list, mix them (do not crush tablets or capsules)
- with an unappealing substance like dirt, cat litter, or used coffee grounds in a container with a lid or a sealable bag. This makes the medication less appealing to children and pets and unrecognizable to someone who might intentionally go through your trash.
- 4. Remove Personal Information:
  Before disposing of prescription
  bottles or packaging, make
  sure to scratch out all
  personal information to
  protect your privacy.
- 5. Liquid Syrups: Place your syrups in an old coffee can filled with coffee grounds or dirt. Place the cap on the can and dispose of it in your trash.

By following these guidelines, you can ensure your prescription drugs are disposed of in a safe and responsible manner.





# **Power Tool Batteries**

Power tools use a variety of battery types, including Nickel Cadmium (Ni-Cad), Nickel Metal Hydride (Ni-MH) and Lithium-ion (Li-ion). Batteries should never be put in your curbside or drop-off recycling container. They can cause fires at the local recycling facility and put recycling workers at risk. In order to safely prepare batteries for recycling either place each battery in its own clear plastic bag before placing it in a storage container or tape the battery terminals with clear packing tape or non-

conductive electrical or duct tape, keeping the label visible so that the battery type can be identified. Participating Lowes and Home

Depot stores will accept batteries from power tools. They can also be recycled at the Canton Recycle Center by appointment at 330-874-2258, opt. 1.

# Propane Tanks (20 lb.)

Most retail stores that sell 20 lb. (gas grill-size) propane tanks offer free exchange programs to get a new full tank. Blue Rhino also offers a free recycling program for 20 lb. tanks that are no longer needed. Write "RECYCLE" on the

tank and take it to any Blue Rhino location. Propane tanks should never be put in your curbside or drop-off recycling container. Even when they seem to be empty, they can retain enough propane to cause an explosion and put recycling workers at risk. Always handle disposal of propane tanks safely to protect yourself and others.



#### **Smoke Detectors**

Follow recycling/disposal instructions from the manufacturer. Most manufacturers will recycle them if you send them back. If not, you may dispose of them in your regular trash.



# **Take-Out Food Containers**

Take-out food containers are not recyclable and should be thrown away in your trash.



# Tires (Residential)

Tires can be recycled at the Canton Recycle Center.

To make an appointment, visit timetorecycle.org or call 330-874-2258, option 1. Note: residentially-generated tires only (passenger, light truck, lawn mower, ATV, bicycle, motorcycle, 3-wheeler, 4-wheeler tires, etc.). Not for commercial, business, non-profit, government, farm or churches. Residents are allowed 10 tires per person per year (on or off rim). You may only transport 10 or less at a time – that is the law. Please bring

your ID with you. Tires generated by businesses, churches, governments, non-profits and farms can be disposed of through Liberty Tire at 330-868-0097 (fees apply).

# Scrap Metal

You can recycle your scrap metal at the Canton Recycle

Center. Call 330-874-2258, option 1 to make an appointment. To comply with state laws designed to deter scrap metal theft, you will be required to show a picture ID which will be scanned for the transaction record.



TVs are accepted at the Canton Recycle Center. To make an appointment, visit timetorecycle.org or call 330-874-2258, option 1 – all televisions are accepted. Flat



screen televisions will be recycled. Tube TVs will not be recycled, but there is no cost to you for disposal.

# **Shredded Paper**

Shredded paper is considered a contaminant and is not recyclable – it should be thrown away in your trash or composted if possible.




# **Yard Waste**


